3. The student’s application is subject to the availability of space within an existing program or class.
4. This form must be signed by the student, parent or guardian, sending school principal or superintendent, and the MSAD #33 Superintendent of Schools.
5. If accepted, it is understood that the student must meet the same academic and behavioral standards required of all MSAD #33 students.
6. An appeal of a denial of admission may be made in writing (by student or parent/guardian) to the MSAD #33 Board of Directors. The School Board’s decision shall be final.
7. Submit completed application to the above address.
